Subject: Inviting application for the Emeritus Scientist Scheme-reg.

Sir.

As you are aware that the Council is implementing a scheme of Emeritus Scientist (ES) in the field of Agriculture and allied sciences to be located at State Agricultural Universities/ ICAR-DUs/ CAUs/ CUs with agriculture faculty/ Centre and State funded Institutions/Organizations under National Agricultural Research and Education System (NARES) as per guidelines of the Scheme (Please visit https://icar.gov.in/sites/default/files/Revised-guidelines-of-ICAR-Emeritus-Scientist.pdf).

Presently, 25 slots of Emeritus Scientists are to be filled up, for which, the online applications are invited from superannuated / superannuating scientist of repute of the level of Principal Scientist/Professor and above from NARES in the field of Agriculture and allied sciences.

The objective of the scheme is to tap knowledge and skill bank of superannuated professionals of NARES by allowing them to complete the nationally important research already underway and also for initiating a new programme in nationally important priority areas, to use the talent of outstanding retired teachers in teaching specialized courses and developing instruction material especially multi-media for use in national agricultural education programme including distance education, especially in those, which are relevant to the research/education programmes of Indian Council of Agricultural Research and Agricultural Universities.

Applications submitted through the executive authority of the Institution where the Emeritus Scientist proposes to carry out the work and are duly recommended with justification will only be considered.

The benefit of the scheme shall be open to all the Principal Scientists and above and also the faculty members of equivalent position including teachers of repute who are physically fit and mentally alert. The applicants having one year of service left or superannuated before one year from the last working day of the month of notification (i.e. 30<sup>th</sup> September, 2021) will only be eligible for consideration under this scheme and may apply online in the prescribed format. In no any other form/mode, the applications would be accepted and will summarily be rejected.

The eligible candidates may apply online through Research Leadership Building System (RLBS) Portal of ICAR accessible on link <a href="http://es.icar.gov.in">http://es.icar.gov.in</a>. In case of any difficulty while applying, they may contact on e-mail cbp@icar.gov.in.

The last date to apply is 31<sup>st</sup> October, 2021. The RLBS Portal shall remain open upto 11:59 P.M. of 31<sup>st</sup> October, 2021. You are requested to bring this to the notice of all eligible Scientists/Professors and sponsor one or two candidates.
