### **Expression of Interest**

Expression of Interest from registered reputed companies is invited for running of newly constructed auditorium at National Agriculture Science (NASC) Complex, Pusa campus, Dev Prakash Shastri Marg, New Delhi-110012, in PPP mode (Revenue Sharing Model).

ICAR has recently constructed a State of Art 1200-person capacity Auditorium at National Agriculture Science (NASC) Complex. This 1200 capacity can be divided into 3 halls of 400 capacity each by sliding fordable partitions. These 3 separate halls of 400 capacity are equipped with separate audio visual and projection facility for organising 3 parallel conferences concurrently.

The salient features of the auditorium are as follows:

❖ Building : Basement+3 floors.

❖ Total built-up area : 20600 sqm

Basement : 5150 Sqm Ground. Floor : 5800 Sqm First. Floor : 5725 Sqm Second .Floor : 4925 Sqm

- ❖ One hall of 1200 persons capacity
- ❖ This one hall of 1200 persons capacity can be divided into three separate halls of 400 persons capacity each by sliding foldable partitions.
- ❖ Out of these three separate halls, one hall of 400 persons capacity will be a combination of Desk Table with mike/speaker facilities.
- Out of these three separate halls, two hall of 400 persons capacity each equipped with hydraulic stages, audio visual and projection facility for each individual zone.
- ❖ 1 nos. Conference Room of 80 persons capacity at First Floor
- ❖ 2 nos. Conference Rooms of 40 persons capacity each at First Floor.
- ❖ 2 nos. Training Rooms of 100 persons capacity each at First Floor.
- ❖ 2 nos. of Greens Rooms adjoining to main stage at First Floor.
- ❖ 3 nos. Room designated as Internet Zone, Business Centre and Office Area in Second Floor.

- ❖ 2 nos. of 200 persons capacity training rooms with retractable seating in ground floor.
  - ❖ A 800 person capacity dining/multipurpose hall
  - ❖ VVIP dining for 30 persons capacity
  - ❖ State of Art Audio Visual Conferencing Facility in auditorium.
  - ❖ Five languages interpretation facilities for all Auditorium divisions
  - ❖ Large lobbies at Ground, First and Second Floor
  - ❖ Under ground parking for 180 vehicles and 600 vehicles parking on ground.
  - ❖ Large Green Landscape area adding to the ambience of the auditorium.

The auditorium has latest HVAC system, Electrical installations, lifts & escalators, Solar plant, structural glazing works and Integrated Business Management System (IBMS)

### Scope of work

The Agency/Company would be expected to carry out the following work: -

- 1.1 Publicity of the auditorium in the print media, electronic media, and social networking sites including arranging publication of articles in leading news dailies/ magazine for attracting the interested Govt. public sector and Pvt Organisations for booking and organising the functions in the auditorium.
- 1.2 Complete housekeeping of the auditorium building.
- 1.3 Arrangement for catering services. (This would be through the catering agency managing the IGH)
- 1.4 Routine/Minor operation and maintenance including electrical and plumbing works.
- 1.5 Providing the audio-visual services to various halls through an authorised OEM (Original Equipment Manufacturer).
- 1.6 Making various arrangements like Floral decorations and direction board for the auditorium/venue, engagement of interpreters, end to end management of events including cultural events and conference etc as per the requirement of clients.

#### Items not included in the scope of work

- i. Internal/external security of the auditorium building.
- ii. Maintenance of horticulture in the front lawn of auditorium.
- iii. Special repairs/major renovation works in the auditorium.
- iv. Operation and maintenance of central Air conducting system (HVAC)
- v. Operation and maintenance of Diesel Generate set.
- vi. Maintenance of electrical substation including HT/LT panel
- vii. Maintenance of water supply pumps
- viii. Repair and cleaning and approach road of the auditorium.

The purpose of the present exercise is to invite expression of interest from interested companies/agencies. This is not to be treated as tender of invitation of bids. After the assessment of EOI, fresh tender/ invitation of bids would be floated.
