1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The Bidder must have successfully executed / completed at least one single order of 80 % of the Estimated Bid Value or 2 orders each of 50 % of the Estimated Bid Value or 3 orders each of 40 % of the Estimated Bid Value for similar service(s) in last three years to any Central / State Govt Organization / PSU / Public Listed Company. Copies of contracts / work orders and documentary evidence of successful execution / completion in support of Past Experience of Similar Services along with names, address and contact details of clients shall be uploaded with the bid for verification by the Buyer.

5. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would

be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Introduction

Indian Council of Agricultural Research

ICAR is an autonomous organization under the Department of Agricultural Research and Education (DARE), Ministry of Agriculture and Farmers Welfare, Government of India. Formerly known as Imperial Council of Agricultural Research, it was **established on 16 July 1929** as a registered society under the Societies Registration Act, 1860 in pursuance of the report of the Royal Commission on Agriculture. The ICAR has its headquarters at New Delhi.

2. The Indian Council of Agricultural Research (ICAR) has played a pioneering role in ushering Green Revolution and subsequent developments in agriculture in India through its research and technology development that has enabled the country to increase the production of *food grains by 5.85 times, horticultural crops by 10.76 times, fish by 18.88 times, milk by 11.67 times and eggs by 63.55 times since 1950-51 to 2019-20*, thus making a visible impact on the national food and nutritional security. It has played a major role in promoting excellence in higher education in agriculture. It is engaged in cutting edge areas of science and technology development and its scientists are internationally acknowledged in their fields.

3. The Council is the apex body for coordinating, guiding and managing research and education in agriculture including horticulture, fisheries and animal sciences in the entire country. With **101 ICAR institutes, 725 Krishi Vigyan Kendra** and **71 agricultural universities** spread across the country this is one of the largest national agricultural systems in the world.

Scope of work

Brief of previous achievement:-

The ICAR was awarded First Prize for its Tableau, 'Kisan Gandhi' in the Republic Day Parade - 2019. Smt. Nirmala Sitharaman, Minister of Defence, handed over the award to the ICAR team on 28 January 2019.

The tableau will be made strictly as per the guidelines issued by Ministry of Defence time-to-time, in this regard.

The work has to be undertaken on a turnkey basis and will include all aspects of fabrication of tableau i.e. from conceptualization, making of designs, modification of designs from time to time as per the requirement and instructions, presentation of the designs before the selection committee of the ICAR and Ministry of Defence, fabrication of the models, modifications thereof as per requirements and instructions, presentation of the model before the committee of ICAR and Ministry of Defence and upon selection of the model, fabrication of the actual tableau as per the requirement, specification, time schedule and instructions by the ICAR and Ministry of Defence.

- I. Providing of suitable/appropriate lyrics, composing of music, arrangements of artists and actual pre-recording of the music for use in the tableau. Arrangements of choreography as per requirement including arrangements of artists, folk dance troupes, etc. The job will also involve actual presentation and display of tableau during the RD parade, full dress rehearsal (if required) and maintenance of required services at the time of presentation during the event.
- II. The turnkey project would also include any other work that may have direct or in direct bearing with the fabrication and presentation of the tableau and may facilitate the project in any manner. Information about ICAR and relevant inputs as required will be made available by the Council. The ICAR/DKMA will have the right to modify, change, accept or reject the work in totality or any part thereof or cancel the project any stage without assigning any reason. The copyright of the work shall vest with the ICAR and it would have rights on the awards won, if any.
- III. The successful tenderer will be responsible for transporting the final tableau in the manner and a place decided by ICAR/DKMA.
- IV. The turnkey project would also include any other work that may have direct or indirect bearing with the fabrication and presentation of the tableau and may facilitate the project in any manner. Policies

The achievements and highlights of the Council should depict through ICAR Tableau in very simple, understandable and attractive way. The Saga of Agriculture, contribution of farmers, scientists and others for research and development, any other remarkable theme suggested by Ministry of Defence could be theme of the ICAR Tableau.

Payment Terms

The Payment to the successful agency shall be made as per following terms and conditions.

- I. **First Level Presentation: At initial stages of presentation for selection of Tableau, Concepts are presented in poster mode.** The poster presentation is made generally in 3 meetings before Selection Committee. The bidder has to present drawings on theme as per directions of ICAR and suggestions of Selection Committee. The bidder has to be present in all selection committee meetings along with material and assist ICAR team in poster presentations being made before selection committee of ICAR/Defense Ministry/Government of India. The bidder will be paid @1.5% of quoted amount after first poster presentation, @1.5% on second presentation and @2% on third and final poster. The total payment will be made after poster first phase of presentations are over.
- II. **Second Level of Presentation:** After selection of Tableau theme at first stage selection, i.e., poster presentations, the bidder has to fabricate 3D model as per approved theme by the Committee and produce suitable theme song. The bidder will be paid @ 5.0% of the quoted value at the end of second level of selection.
- III. **Fabrication of Tableau on Tractor and Trolley base at Designated place. After selection in second stage,** the bidder has to prepare real Tableau for participations in Republic Day Celebrations. Third payment @40% of quoted amount will be released after approval of 3D modal and before First Full Dress Rehearsal at Rajpath in respective years.
- IV. **Final Payment:** After successful participation of the Tableau in the Republic Day Celebrations on 26th January, remaining 50% payment will be released after submission of bills etc.

Other Terms and Conditions

- V. Deduction at source for income tax or any other tax as applicable shall be made as per law.
- VI. The Council shall stand indemnified for any liability for default of payment by the agency to the parties involved or engaged by it for this project.
- VII. The Council will not pay any additional cost of any kind for any work that the agency may have to undertake in course of the project beyond agreed amount as per tender.
- VIII. The quoted price will be paid stage wise, and on the basis of success. The bidder having highest marks in total of technical and financial marks will be the H1 bidder.

Evaluation:

- i. The proposals received in time will be screened based on their responsiveness (i.e. Submission of all the requisite documents as asked for in this tender) and eligibility criteria.
- ii. The successful bidder will be given an offer letter and will be asked to submit Performance Bank Guarantee (PBG) @ 10% of the total work order cost. The bidder is required to submit unconditional acceptance of the said offer letter and PBG as required. These will be required to be submitted within 07 working days of issue of the offer letter. In case of non-submission of the same, EMD of the bidder is liable to be forfeited and the bidder blacklisted apart from any other action which ICAR-DKMA may take as deemed fit by competent authority.
