- III) In some Institutes Guest Houses few rooms are always kept idle/vacant for priority allotment and due to this huge revenue loss and inconvenient to the other guest has been experienced. It is therefore, decided that in future no rooms should be kept for priority allotment. In other words all the rooms of Guest House should be allotted.
- IV) The charges of Farmers Hostels/ Dormitories may be fixed at individual institute level as per their requirement. However the rates may not be exceed Rs. 50/- per bed per person per day.
- V) The Guest House Room Rent charges are on existing pattern i.e. if a single bed (3'X6') arranged in one room, the charges should be per room per person per day. Two beds or more arranged in one room, the charges should be single bed per person per day.

These rates are made effective with immediate effect and the other rates recommended earlier shall be same. It can also be viewed from www.icar.org.in.
