1. The agency must provide minimum wage, EPF, ESI and other statutory benefits to the persons e ngaged for Garden Maintenance Work at ICAR-N RC on Pig, Guwahati as per Govt. of India (Centra I Govt. India) rules i.e. Minimum rate of Govt. of I ndia must be followed i e Minimum wages as per the Ministry of Labour & Employment, Govt. of In dia, rules and acts applicable for the workers not ified for "B AREA" shall be followed. Further VDA and other statutory allowances to the workers sh all also be paid by the agency at revised rate, wh enever the same is revised/enhanced by the Mini stry of Labour & Employment, Govt. of India. 2. The amount shall be quoted in the price bid by the agen cy for the period of one year (12 months) inclusive of all t axes and charges after taking into consideration all the as pects as mentioned in the scope of work and terms & cond ition of the bid/contract.

4. As the contract amount will be fixed for the period 1 ye ar (12 months) therefore, the agency should quote the am ount in the price bid after taking into consideration all the costs like payment of wages to the labours following mini mum wages rate, others rules & regulation of govt. of Indi a, cost of material & items as indicated in scope of work a nd provisions for payment of unforeseen expenditure that may arise in due course like increase in VDA, Statutory Lia bility- ESI, EPF etc.

5. The payment will be made to the agency on monthly ba sis by dividing the total contract amount by 12 months.

6. The payment will be made only after satisfactory perfor mance, clearance of statutory liabilities and submission of necessary documents in this regard by the agency.

7. The agency has to comply the rules and regulations strictly provided by th e Ministry of Labour, GOI from time to time and it will be responsible for obser vance of all provisions of Contract

Labour (Regulation and Abolition) Act 1970 revised from time to time. The institute will not be responsible for any violations related to labour management by the successful bi dder.

8. The contract is for a period of one year initially which may be extended on

the approval of Competent Authority and strictly following the conditions of co ntract failing which contract is liable to be terminated.

9. Mode of Payment:

ICAR-NRC on Pig shall make payment through PFMS/ RGTS in favour of the agency. 10. Termination: This contract can be terminated by giving one month's notice on either side and that any notice required to be s erved shall be sufficiently served on the parties if delivered to the m personally or dispatched at the address herein given under reg istered post. The ICAR- NRCP will not have any responsibility towa rds this for any damage/ loss caused and it cannot be challenged in any court of law.

11. The contractor is advised to do a complete survey to assess the site and quantum of work of the tend er prior submitting the rates/ submission of tender.

- 12. In case of any dispute arising, decision of Director, ICAR-NRC on Pi g will be final and binding.
- 13. An amount of 5% of the contract value is to be de posited by the selected/ successful tenderer as a se curity deposit only after receiving communication f rom the ICAR-NRC on Pig. In the event of non -depo sition of the same, the earnest money will be forfei ted.
- 14. GST & Other Taxes will be pad as applicable as per Govt. of India r ules.

15. Director, ICAR-NRC on Pig reserves the right to reduce or ter minate the period of contract or to extend its duration in the inter est of the council/Institute for any justifiable reasons, not mandat ory to be communicated to the tenderer.

16. Incomplete bid or not complying with the above condition is liable to be rejected.

17. If the date upto which the bids is open for acceptance is decla red to be a holiday the tenders shall be deemed to remain open f or acceptance till the next working day.

18. No interest will be paid against EMD and security deposit.

19. 22. ICAR-NRC on Pig, Guwahati may ask the agency to produce th e documents regarding payment of wages & statutory liabilities a t any time and the agency shall produce the documents accordin gly.

23. The personal engaged by the agency for this job contract will not be an e mployee of the council/ICAR-NRC on Pig and there will be no employer- emplo yee relationship between the council/ICAR-NRC on Pig and the personnel so en gaged by the contractor.

24. The agency shall be wholly responsible for making payment of monthly sal aries and other admissible allowances to the personnel under minimum wage s act and the council/ICAR-NRC on Pig shall in no way be responsible for meeti ng any kind of expenditure on salaries etc. to these personnel individually.

25. Only those firms will be considered for financial bid opening who will qualify in the technical bid. Financial bid will be opened o f technically qualified firms. The ICAR-NRCP will award the contra ct to the responsive bidder whose total cost for all the items put t ogether is the lowest. **Terms of the contract** :
