A Walk-in-Interview will be held for selection of 10 Young Professional-II at a fixed emolument of ₹42,000/- (Forty-two thousand only) per month on Short Term/Contract basis in ICAR Agricultural Education Division & Internal Finance Division, ICAR, New Delhi-110012. ## **Terms & Conditions:**

1. The positions are purely temporary and will be filled on contractual basis till the termination of the scheme or as per the need, whichever is earlier. Initial engagement will be for one year and duration of engagement can be extended up to two years (1+1 year) as per need and subject to satisfactory performance of the candidate.
2. Engagement of YP will be subject to relevant rules and guidelines of ICAR & amendments thereof.
3. The engagement will not constitute a right of regular job or appointment of any nature in the ICAR/Agricultural Education Division. The working hours will be same as regular employees of ICAR. No extra benefit will be allowed for working beyond office hours.
4. The minimum age of candidate should be 21 years and maximum 45 years (with relaxation as per rules) on the date of Walk-in-Interview.
5. Candidates will be selected through Interview on the basis of their academic qualification, experience, achievements/awards, etc. which are submitted by the candidates in his/her application form (Annexure-II).
