# Office Memorandum

Subject: - One-time relaxation in Rule 10 of CGGPRA Rules, 2017 in exercise of the powers conferred under Rule 83 of CGGPRA Rules, 2017.

It is seen that many applicants who are to superannuate within six months and have no accommodation of their own at the new place of posting are unable to apply for allotment of GPRA, due to restriction under Rule 10 of CGGPRA Rules, 2017.

- 2. The matter has been considered in the Directorate. It has now been decided by the Competent Authority to reduce the period mentioned in provision of Rule 10 from six months to two months, in relaxation of Rule 10 of CGGPRA Rules, 2017 in exercise of the powers conferred under Rule 83 of CGGPRA Rules, 2017 so that they can avail the facility of GPRA in the new place of posting on fulfilment of other conditions laid down in CGGPRA Rules, 2017.
- These orders shall be applicable with immediate effect until further orders.
