OFFICE ORDER

The Government of India has approved restructuring of the Agricultural Scientists Recruitment Board (ASRB) in a decision taken in the meeting of the Union Cabinet held on 1st August, 2018 vide circular No. 25/CM/2018(i) dated 06.08.0218; Case No. 213/25/2018 (Item-7). The decision has been notified in the Gol Gazette on 09.08.2018. Consequently, the ASRB has been delinked from ICAR and attached with the Department of Agricultural Research and Education (DARE) under the Ministry of Agriculture & Farmers Welfare, Gol. As per this decision, the Board shall have its own Cadre of administrative staff in the secretariat and have independent administrative control on the said cadre.

As a result of this restructuring, it has also been decided that the present 40 incumbents/employees of ICAR posted to work in ASRB (in the list attached as Annexure), originally borne on the establishment of ICAR Headquarters, shall in the transition period continue to work there. They will be treated as on 'deemed deputation' without any deputation allowance with ASRB from the date of its delinking i.e. 9th August 2018 (date of notification), in terms of the provisions contained in Para 2.2(e) of the DOP&T OM No.6/8/2009-Estt.(Pay II) dated 17th June, 2010. This arrangement will remain in place till the regular positions are created for ASRB and the mode of filling up the said positions is approved/decided or until further orders, whichever is earlier.

This issues with the approval of DG, ICAR.
