Sub.: - Contract with CPWD for deposit works in respect of ICAR and its Institutes-reg. Ref.: - Letter of even number dated 13.09.2021
Sir,

This is in continuation of the Council's letter of even number dated 13.09.2021 wherein your kind attention was drawn towards the following points in respect of deposit works (capital/Repair & Maintenance) carried out by CPWD for Indian Council of Agricultural Research (ICAR) Headquarters in New Delhi and all its 118 Institutes across India:

- Settlement of old outstanding advances with CPWD is a major area of concern where a lot of old outstanding advances paid to CPWD are still left unadjusted for the want of final expenditure statement submitted by CPWD (Form 65). In absence of adjustment, the assets are neither being capitalized nor put in use.
- External (C&AG) and Internal Audit Paras are still pending due to non-adjustment of outstanding advances given to CPWD, delay in work completion, pending handing over of the works etc.
- The cases have been observed where the work has been completed by the CPWD but still awaiting handing over to the ICAR Institutes, C&AG Auditors adversely commenting on this from years together.

To address these issues in a time bound manner, a list of outstanding advances against CPWD in respect of all 118 units/Institutes of ICAR has been prepared and attached with this letter for your ready reference. You are once again requested to issue necessary instructions to all CPWD offices engaged with ICAR and its Institutes for early settlement of pending outstanding advances to enable us to settle related long pending Audit paras on priority.
