This has reference to CPWD's letter no. F.No. 7/10/2021-W.II/DG/38 dated 24.03.2022 wherein, in response to our communications regarding settlement of old pending CPWD advances in respect of ICAR and its Institutes PAN India, your Good Office had directed the regional offices of CPWD for the settlement of these advances at the earliest and forward the report to the Council within one month. Now, more than a month has already elapsed and we are yet to receive report from CPWD in this regard.

As informed earlier, there are many Audit Paras from the office of C&AG that are outstanding since several years regarding unadjusted CPWD advances in respect of ICAR Headquarters and its Institutes. The progress of settlement of Audit paras are being presented in monthly meetings of the Seniormost Officers in the Council and report also is submitted to the Hon'ble Minister of Agriculture and Farmers Welfare through Governing Body of ICAR and Annual General Meeting headed by the Hon'ble Minister.

You are, therefore, requested to have a personal look in the matter and have the Action Taken Report (ATR) from your good office at the earliest regarding the adjustments of outstanding CPWD advances and forward the same to this office so that the same can also be intimated to the office of the Hon'ble Minister and the C&AG Auditors for settlement of pending Audit Paras. We have also issued necessary instructions to the Directors of the ICAR Institutes to co-operate with regional offices of CPWD and provide any assistance required.
