

Sub: Cases relating to booking of air tickets through unauthorized airlines: reg.

With reference to the OM No. 19024/03/2021-E.IV dt. 31.12.2021 and subsequent OM dt. 16.06.2022 already endorsed in the council vide Letters No. FIN/22/1/2016-CDN(A&A) dt. 06.01.2022 and 04.07.2022 respectively, it has been observed that *there are various cases coming up seeking one-time relaxation for booking of air ticket through unauthorized agents citing their circumstances/justifications* that are mostly due to unawareness.

In this regard, it is requested to all the SMDs/Sections/Officers of the Council to strictly adhere to the guidelines stated above. Further, while extending invitation to non-officials for a meeting, SMDs may indicate the rules in speaking terms to avoid any such case. Request for relaxation of booking of air tickets by any unauthorised means will not be considered in the Council except in cases where tickets are bought under unavoidable circumstances.
