Respected Sir,

I am writing to you in connection with complaints regarding delays in revision of pension of pre-2016 pensioners, based on the decisions taken on the recommendations of the 7th Central Pay Commission.

2. You would kindly recall that orders for revision of pension of pre-2016 pensioners (including pensioners belonging to All India Services) were issued by Department of Pension & Pensioners' Welfare vide O.M. No. 38/37/08-P&PW dated 04.08.2016 and O.M. No. 38/37/08-P&PW dated 12.05.2017. For the convenience of the Pension Sanctioning Authorities, ready-reckoners/concordance tables for revision of pension were also circulated vide O.M. No. 38/37/08-P&PW dated 06.07.2017.

3. Representations from pre-2016 pensioners have been received in this Department stating that their pension has not been revised and revised Pension Payment Authority has not been issued, although a period of more than five years has elapsed since the issue of orders for revision of pension. This is a serious matter and needs immediate attention.

4. I shall, therefore, be grateful if you could kindly look into this matter personally and get an 'exception list' prepared in respect of all the pensioners under your administrative control, in respect of whom revised pension payment authority has not been issued after 7th CPC. The list should indicate the name, PPO number and date of retirement of the pensioner along with the reasons for non-issue/delay in issuing the revised pension payment authority. A copy of this list may also be sent to this Department.

5. The Parliamentary Standing Committee of the Department in its 120th Report presented to Rajya Sabha/ laid on the Table of Lok Sabha on 8th December, 2022 has recommended strict punitive action against officials habitually responsible for such kind of non-redressal of grievances of Pensioners. Therefore, you may also like to fix responsibility for any inordinate delay in revision of pension under intimation to this Department.
