
Sir,

No. 185/AS/FA dated 03.11.2023, subject to observance of (i) all relevant rules and codal formalities; (ii) the expenditure should be as per ceilings fixed by ICAR/Govt. of India.

3. The applicant may be relieved after completing pre departure formalities. He may be directed to upload the deputation report (including actionable items for ICAR and institute concerned) on the FVMS portal and to submit a copy of the same to concerned SMD of ICAR, New Delhi and ADG(IR), ICAR, New Delhi within one month of the programme.
