I am directed to convey the approval of the competent authority of this department to the foreign visit of Dr. Joykrushna Jena, DDG (Fy.Sci.), ICAR Headquarter, New Delhi as a member of the delegation led by Dr. L. Murugan, Hon'ble Minister States for Fisheries, Animal Husbandry & Dairying, Government of India with reference to the invitation received from HE Mr. Damitry Patrushev, Minister of Agriculture Russian Federation to have an official visit to Moscow on the eve of the 6th International Fisheries Forum and the Exhibition of Fishing Industry and Seafood and Technology to hold bilateral talks on major issues on bilateral agenda, at Moscfow and Saint Petersburg, Russia during 25th to 28th September, 2023 (excluding journey time). 2. The expenses on the foreign visit amounting Rs. 4,90,000/- shall be borne by the ICAR Hqrs (Foreign TA). This has the concurrence of AS & FA vide Dy. No. 133/AS/FA dated 21.09.2023, subject to observance of (i) all relevant rules and codal formalities; (ii) the expenditure should be as per ceilings fixed by ICAR/Govt. of India.

3. He may be relieved after completing pre departure formalities. He may be directed to upload the deputation report (including actionable items for ICAR and institute concerned) on FVMS portal and a copy of the same to ADG (IR), ICAR, New Delhi within one month of his return from tour programme.
