### OFFICE ORDER

Whereas the disciplinary proceedings were initiated against Shri D.K. Agnihotri, Assistant Finance & Accounts Officer, IIVR, Varanasi vide IIVR's Memo No IIVR/Vigl/2013/3-1/445 dated 15.10.2013.

2... Whereas the disciplinary proceedings have been dropped vide Institutes Order No IIVR/Vigl/2013/1410 dated 29<sup>th</sup> September, 2016 after an inquiry was held as per the prescribed procedure.


3. Whereas upon dropping of the charges against Shri D.K. Agnihotri, it was decided with the approval of the competent authority to open the sealed cover proceedings of the DPC Meeting held on 26<sup>th</sup> November, 2015 in which he was considered for promotion to the post of Finance & Accounts Officer.

4. Whereas upon opening of the said sealed cover it has been found that the DPC dated 26<sup>th</sup> November, 2015 has recommended Shri D.K. Agnihotri for promotion to the post of Finance & Accounts Officer.

5.. Now, in view of the recommendations of the DPC meeting held on 26<sup>th</sup> November, 2015 it has been decided with the approval of the competent authority to promote Shri D.K. Agnihotri, Assistant Finance & Accounts Officer to the post of Finance & Accounts Officer in PB 3 of Rs.15600-39100 + Rs.5400 (Grade Pay) on notional basis with effect from 31.12.2015 i.e. from the date of joining of his immediate junior viz. Shri K.S. Sreekumaran on the post of F&AO on promotion.

6. Upon his promotion as Finance & Accounts Officer, Shri D.K. Agnihotri is posted at IIPR, Kanpur. The actual date of promotion to the post of F&AO will be from the date he assumes the charge of the said post at IIPR, Kanpur. Shri Agnihotri will be entitled for TA/DA on posting to IIPR, Kanpur. The pay of Shri Agnihotri may be re-fixed and regulated accordingly.

7. The issue regarding pay of arrears of pay and allowances will be decided and communicated later on.
