Sir,

I am directed to refer to Commission's letter No. 437/6/1/ECI/INST/FUNCT/MCC/2018 dated 27<sup>th</sup> March, 2018, and to state that the provisions of Model Code of Conduct is enforced from the date of announcement of election schedule by the Election Commission and it remains in operation till completion of election process.

Now, that the declaration of result in respect of Karnataka has been completed, the Model Code of Conduct has ceased to be in operation in the State of Karnataka with immediate effect except in the districts where the poll for <u>two</u> Assembly Constituencies, namely 154-Rajarajeshwarinagar and 173-Jayanagar have been deferred/adjourned.
