OFFICE MEMORANDUM

Subject:- Strengthening of administration – Periodical review under FR 56/Rule 48 of CCS (Pension) Rules, 1972.

The undersigned is directed to refer to DoP&T's O.M. No.25013/1/2013-Estt.(A) dated 21.03.2014 and No.25013/01/2013-Estt.A-IV dated 11.09.2015 on the periodical review under Fundamental Rules 56 or Rule 48 of CCS (Pension) Rules, 1972. In the recent past, many changes in the nomenclature of the posts and in the areas of responsibility have been taken place. Accordingly, in order to simplify and speedup the procedure of review, it has been decided by the Council to revise the existing composition of the Review Committees to review the cases of officers/staff in ICAR system. The composition of the Review Committee(s) and Internal Screening Committees for the purpose are detailed in the succeeding paras.
