## OFFICE ORDER

Both the lady officers are retained at their present place of posting for the time being, in view of the fact that transfers/postings in the Finance cadre are likely very soon due to promotions in the grade of Director (F)/Comptroller and DD (F)/CFAO owing to a number of retirements in the month of January, 2019. This will result in promotions/posting in the lower grade of SFAO & FAO also. They will be considered for appropriate posting then.

3. In the event of their declining promotion or not reporting for duty at the place of posting within 30 days from the date of issue of this Office Order, the offer will stand cancelled and they will be debarred from further promotion for a period of one year, as per rules.

4. This appointment will be subject to outcome of OA No.100/2858/2017 vide which seniority of Finance and Accounts Officer finalized and circulated on 10.11.2017, has been challenged before Hon'ble CAT(PB), New Delhi.
