#### Office Memorandum

It has been decided by DG, ICAR & Secretary, DARE to complete second phase of scientific cadre review exercise through three-way consultation among Institutes, SMDs and the Cadre Review Committee (CRC). Accordingly, following guidelines, procedure and time schedule have been decided to be followed for second stage: -

### Guidelines to be followed for submission of Cadre Strength Review by the Institute & the SMDs:

- I. The Institutes will identify the requirement of scientific manpower in prescribed formats (Annexure I-3) keeping in view:
  - (i) Mandate of the Institute
  - (ii) In-position strength of scientists, including temporary arrangement made with respect to distortions against a vacancy in the existing sanctioned strength in respective category.
- 2. Revised cadre strength so proposed by the Institutes/SMDs must specifically clarify the following points, wherever applicable, while proposing revised cadre strength:
  - (i) Whether to continue with the existing cadre strength and existing ARS disciplines sanctioned at the Institutes (including the temporarily accommodations w.r.t. distorted postings, if any, at the concerned institute) or the sanctioned strength or disciplines are to be revised, specifically commenting on the disciplines of the temporarily adjusted scientists in the revised cadre strength.
  - (ii) In case not to continue with the temporarily accommodated distorted scientists, then recommendations to be made specifically for transfer of the concerned scientists.
  - (iii) Proposal should take in to consideration number of positions, if any, (a) got received from other institutes or (b) got adjusted for other institutes during the course of temporary arrangement made for accommodation of distorted postings.
- 3. While revising the cadre strength care must be taken to restrict the total number of positions in each category (HoD/PC/Principal Scientists, Senior Scientist & Scientist) as per existing cadre strength. However, in case of increase/decrease in total number in any category for an institute it must be restricted to SMD wise total sanctioned strength in concerned category i.e., Principal Scientist/Senior Scientist/Scientist.

Procedure to be followed for conducting the process of Cadre Strength Review:

- 4. The proposal of revised cadre strength of scientists, in the manner indicated above, will be forwarded by each Institute to the concerned SMD. The concerned SMD will compile the inputs of all the Institutes of the SMD and forward a consolidated proposal containing proposed cadre strength for each of the Institute [cadre-wise(S/SS/PS/HD/PC), discipline-wise and Regional Stations/Centre/Unit-wise etc.] to Director (P) hard copies as well as soft copies.
- 5. Thereafter cadre review exercise will be moved forward through three-way interaction in following manner: -
  - (i) In Ist stage interaction the Directors and CAO/SAO/AO of the Institutes along with Director/ Deputy Secretary/Under Secretary of the concerned SMD will have an interaction with Director (P) for preliminary screening of the proposal of Institutes w.r.t. the number of existing and proposed HODs/PCs/PS/SS/Scientist for each Institute.
  - (ii) In 2<sup>nd</sup> stage interaction the SMD will again interact with the Institutes regarding whose cadre review proposal the Personnel Division have made some observations and review and revise the proposal, if required, as per the observations made during the I<sup>st</sup> stage meeting.

Tentative time for completing  $2^{nd}$  stage meeting i.e. internal meeting by each SMD with its Institutes

- Maximum 2 days for CS/AS/Hort./NRM
- Within I day for Agri. Extn./Agri. Engg./ Education/Fisheries Science.
- (iii) In 3<sup>rd</sup> stage meetings, the CRC under chairmanship of the DG, ICAR would have interaction with each SMD to finalize instate wise revised cadre strength one-by-one in the presence of Directors of the concerned institutes.
