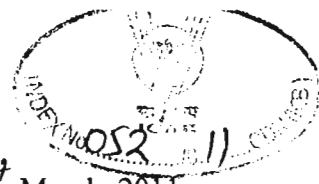

OFFICE ORDER

Consequent upon the implementation of the recommendations of Task Force constituted under the Chairmanship of Dr. Narendra Jadhav, Member, Planning Commission for review of the operational guideline implementing of Tribal Sub-Plan (TSP), the Competent Authority in the Indian Council of Agricultural Research has approved the creation/ setting up of a '**Tribal Sub-Plan (TSP) Cell**' at ICAR Headquarters. This cell shall function under the overall supervision of the Liaison Officer for Scheduled Caste/ Scheduled Tribe who would also be the Nodal Officer for ensuring effective and meaningful implementation of the Tribal Sub Plan. While the allocation of funds for Tribal Sub-Plan under Plan outlay shall be the responsibility of the PIM Section of the Council, the TSP Cell would be responsible for proper monitoring of Tribal Sub-Plan funds and also for looking after the interests of Scheduled Tribes in the Council with the clear objective of bridging the gap in socio-economic development of the Scheduled Tribes.

The staff strength of this Cell through internal re-deployment shall be as follows:-
