- 3. The officers concerned may kindly be informed that in case any of them absents himself/herself from invigilation duty without timely prior intimation to the Union Public Service Commission or arrives at the centre late or is reported by the Supervisor to be non-cooperative or found negligent in his/her duty or his/her performance is otherwise reported to be unsatisfactory, his/her name will be removed from the panel of invigilators maintained by the Commission.

## UNION PUBLIC SERVICE COMMISSION Civil Services (Preliminary) Examination, 2014 INSTRUCTIONS TO INVIGILATORS

The instructions as detailed below must be strictly complied with by the invigilators:

The invigilators must report to the supervisor **one hour before** commencement of examination. Ascertain room/hall and name of fellow invigilator where duty is to be performed.

- 2. Obtain answer sheets, attendance lists, seating plan with series of test booklets marked thereon. Important announcements to be made by the Invigilator and timing of the same is annexed.
- 3. Candidates with valid e-Admission Certificate to be allowed entry in the examination hall/room, 20 minutes before commencement of examination in each paper.
- 4 (i) If the Admission certificate is reported to have been lost or is otherwise not produced but name of the candidate is included in the attendance list, the candidate should be allowed to take the examination in the first session and asked to furnish photograph and written undertaking indicating therein, the circumstances and stating that he/she is appearing in the examination at his/her own risk. Candidate should be asked to download his Admission Certificate from UPSC website and produce a copy of the print out of the Admission Certificate in the second session of the examination.
- (ii) Candidate has valid admission certificate but name is not included in the Attendance List;

Necessary entries regarding the Roll No. and name should be made in the blank proforma of Attendance list. Duly attested passport size photograph should be pasted in the space provided for the purpose and candidate should fill the relevant columns in the Attendance list. Above procedure be followed for each session of examination.

(iii) In case there is no photgraph on e-Admission Certrificate or there is disparity between the photo of the candidate as printed in the admission certificate and Attendance lists and actual physical appearance, the candidate should be allowed to take the examination at his own risk with undertaking subject to production of proof of identity such as Identity Card or Voter Identity Card or Passport or Driving License etc. He should be asked to produce photograph on the same day

in the next session, which should be fixed on undertaking and signed by the candidate and attested by the Invigilator and Supervisor.

- (iv) If a candidate who is absent in the first session, reports for the examination in second session, he/she may be allowed to appear in the second session. Attendance list should be got filled in for the second session only.
- Mobile phones or any other electronic equipment or any other equipment capable of being used as a communication device or reference books, electric/electronic calculators, bags, lunch boxes etc. are not allowed inside the Examination Hall. The candidates, invigilators and other examination functionaries are also not permitted to bring mobile phones and other communication devices to the examination hall.
- 5.(a) Use of Mobile phones by the Invigilators is also prohibited. The venue Supervisor should ensure that the Invigilators and other examination functionaries do not carry Mobile phone with them in the Examination hall/room.
- 5.(b) The Invigilators and Assistant Supervisors should be careful and vigilant regarding any suspicious activity by the candidate particularly of the use of Blue-tooth/Small cameras fitted on watches etc used by the candidates for cheating.
- 6. One Answer Sheet per candidate is to be supplied. No paper for rough work is to be provided separately.
- 7. Test booklet will be delivered to Invigilator five minutes before the commencement of examination in each session. Ensure test booklets are properly arranged as per test booklet series indicated in the seating plan.
- 8. Test booklets be distributed in vertical rows, three minutes before commencement of examination. No test booklet should be left on the tables not occupied by any candidate.
- 9. Candidates are not to be admitted after ten minutes of the scheduled time of commencement of the examination in each session. No functionary has any discretion in this regard. After expiry of ten minutes invigilators should return spare copies of test booklets and answer sheets to the supervisor.
- 10. After expiry of ten minutes from the commencement of examination if any candidate brings to notice of invigilator any defect in his test booklet, matter be reported to the supervisor immediately for replacement of defective test booklet with another booklet of the same series. Necessary correction with regard to Serial No. of test booklet is to be made by the candidate in the Attendance list:

- 11. After expiry of ten minutes from commencement of examination in each session, check that candidate has filled in all particulars on the answer sheet and test booklet correctly. Corrections/changes in roll number be initialed by candidate as well as Invigilator and countersigned by Supervisor. Invigilator should also encode in Black ball point pen the series of the Test Booklet at the appropriate space provided in the answer sheet (left hand corner bottom).
- 12. The Commission has introduced Scannable Attendance List of candidates. As these Scannable Attendance List are to be computer compliant, it is expected that these are handled with utmost care as is done in the case of Answer Sheet (OMR Sheets). Please note that even if a portion of this Attendance List is torn off, or is mutilated or spoilt, there may be difficulty in scanning of the Attendance List. Pins, tags or punch holes must also not be used with the Attendance List as the same shall obstruct/interfere with the mechanical processing of these sheets.

The Attendance List shall contain two columns in six separate boxes, one for each candidate, arranged vertically in serial order. These lists shall contain candidate's name, photograph, roll no. facsimile signature as in the application form, oval inscribed 'P/A', space for entering the serial no. of the Test Booklet and Answer Sheet. The candidate shall be required to fill in the relevant particulars in 'Black' ball point pen\_against—their columns. After darkening the oval inscribed 'P' and making entries in relevant columns, the candidate is required to append his/her signature in 'Black' ball point pen\_in the presence of Invigilator.

In respect of candidates who are absent, the Invigilator shall mark them as absent by darkening the oval **inscribed 'A'** in black ball point pen, in the relevant column. After getting each sheet of the list completed, the Invigilator is also required to sign the Attendance List in the space provided for the purpose in token of his/her confirmation of the identification of the candidate and also verifications of the relevant particulars entered by the candidate in the Attendance List.

13. After answer sheets and test booklets have been provided to candidates, their identity should be checked with the photograph and facsimile signature in the attendance list. Check that candidate has written correctly answer sheet number, test booklet series, serial number and also darkened the oval inscribed 'P' in token of his/her attendance in the relevant column of the attendance list in Black ball point pen. Thereafter, invigilator should sign in Black ball point pen the attendance list in the space provided for the purpose.

- 14. There would be a bell at half time and a warning bell five minutes before the completion of the examination when the doors of the room/hall should be closed. When the bell for completion of examination rings invigilator will announce "time is over, stop marking, close your test booklets and remain in your seats till answer sheets of all candidates have been collected and accounted for."
- 15. Candidates are not permitted to leave the Exam Hall/Room till expiry of the full allotted time.
- 16. Invigilator should accompany a candidate to the toilet so that he remains within his full view. No candidate should be allowed to go out for any other purpose. While going to toilet candidate should turn his answer sheet upside down. Candidate should not be allowed to take with him the Test Booklet and Answer Sheet out of the examination hall/room.
- 17. No candidate is allowed to go to the toilet during the last 30 minutes of the examination.
- 18. Collect answer sheets from all candidates and hand over to Supervisor immediately on completion of the allotted time for each paper. Invigilators will be personally responsible for loss or misplacement of any answer sheet.
- 19. Invigilators should remain alert and should not engage in conversation with other Invigilators. He/she should ensure that no candidate copies or attempts to copy from the papers of any other candidate, nor permit his own papers to be copied, nor attempts to give, nor obtains, nor attempts to obtain irregular assistance of any description and that no candidate indulges in disorderly or improper conduct and violates such further instructions as may be administered in the Examination Hall by the Supervisor/Invigilator.
- 20. If any candidate raises a doubt about any apparent mistake, ambiguity or anomaly about any item in the Test Booklet, he may be advised to answer the item as it is and make a representation to the Commission. In his/her representation candidate should indicate name of examination, his/her full name, roll number, name of the subject, centre, serial number and series of the test booklet, serial number of the item and nature of mistake/ambiguity. The candidate may be informed that the Commission will take due note of his representation while evaluating the Answer sheet.

AND THE PROPERTY OF THE PROPER

21. Candidate(s) will mark responses himself/herself in the Answer Sheet by blackening completely the correct circle (a or b or c or d) by black ball point pen. Candidates may be advised not to use ink pen as it may create smudges on the answer sheet which may obstruct/ interfere with the mechanical scoring of the answer sheet. Help of any other person to mark responses is not allowed **except in case of visually challenged candidates.** 

## 21.A SEPARATE OMR SHEETS & TEST BOOKLETS FOR PAPER-I & PAPER-II FOR VISUALLY CHALLENGED CANDIDATES

Utmost care must be taken to ensure supply of correct OMR Sheet & Test Booklet to Visually Challenged candidates as per the following table:-

- 22. If a candidate slips away from the bathroom, he/she should not be allowed to reenter the examination hall/room and the case should be referred immediately to the Supervisor in writing.
