Subject: Change in authorized Bank signatories in Treasury Single Account: regarding

The Council is in receipt of number of references from institutes seeking procedure for change in authorized signatory in Treasury Single Account being maintained with the RBI due to transfer/promotion of present signatories. The matter has been taken up with RBI and accordingly, procedure for change in authorized signatory will be as under:

The application for change in authorized signatory must have the following:

- a. Triplicate (3 copies) of signatures of signatory. The signatures of the new comer signatory must be attested by the person who is the existing signatory of the account.
- b. E-mail id and contact no. of the signatory.
- c. KYC documents of the new signatory.

The application in prescribed format, as attached as annexure to this circular should be signed by existing authorized signatory only. The request for change in name of authorized signatory must be routed through the nodal officer at Council.
