It has come to notice of the Council that a Notification No. F. 18-19/75/T2 dated 26.5.1977 under the subject "Recognition of Technical and Professional Qualifications", purportedly issued by the erstwhile Ministry of Education & Social Welfare (Department of Education Technical) conveying the decision of the Govt. of India 'to recognise a Diploma in Engineering in appropriate discipline plus total ten years of technical experience in the appropriate fields is recognised as equivalent to degree in Engineering and is considered valid for the purposes of selection to Gazetted posts and services under the Central Govt. or State Govt', has been in circulation.

It is submitted for the information of all the institutes under the Council that the matter contained in this communication dated 26.5.1977 has been declared fictitious by the Hon'ble Central Administrative Tribunal, Chandigarh Bench at Chandigarh vide its judgement in OA No. 343-PB-2013 pronounced on 15.12.2015. This was followed by Gazette Notification dated 23.03.2016 by the Ministry of Human Resource Development(MHRD), Deptt. of Higher Education.
