# PROCEEDINGS OF THE $37^{TH}$ CENTRAL JOINT STAFF COUNCIL MEETING HELD ON $21^{ST}$ JUNE, 2017 AT A.P.SHINDE SYMPOSIUM HALL, NASC COMPLEX, NEW DELHI

The 37<sup>th</sup> meeting of the Central Joint Staff Council(CJSC) of the Indian Council of Agricultural Research was held at Symposium Hall, NASC, Pusa, New Delhi on 21<sup>st</sup> June, 2017 under the Chairmanship of the Director General, ICAR. List of Participants is enclosed as at Annexure 'A'.

- At the outset, Hon'ble Director-General, ICAR, Dr. Trilochan Mohapatra, welcomed all dignitaries and all CJSC members present in the hall. Shri Chandrashekhar, Secretary (Staff Side), who was due for retirement on attaining the age of superannuation w.e.f. 30-06-2017 was felicitated with flower bouquet and a shawl for his contribution to the CJSC. Shri Someshwar Mishra, the longest standing CJSC member veteran member from Indian Institute of Sugarcane Research, Lucknow was also felicitated as he was also superannuating on 30.06.2017.
- Hon'ble Chairman informed the house that our Hon'ble Union Minister of Agriculture & Farmers Welfare, has been taking interest in resolving the issues. Chairman also applauded Hon'ble Secretary, ICAR, Shri Chhabilendra Roul for rendering excellent contribution not only for CJSC platform but also for the entire ICAR system. Chairman explained as how MIS on scientific personnel information has been compiled and acted upon in the interest of scientific temper. He stressed the importance of digitization and transparency for completion of tasks timely and efficiently. He called for working together for quick results in short time.
- Hon'ble Chairman appreciated outgoing Secretary (Staff Side), CJSC for his contribution
  in presenting various issues in a proper way and voicing for the cause of employees.
  Chairman felt sad to miss his voice in future CJSC meetings. He also stated that Shri
  Chandrashekhar made all his efforts for garnering the support of all in addressing various
  staff welfare issues and because of that things are still moving forward as nothing can be
  done at once.
- Hon'ble Chairman stressed for conspicuous contribution by all personnel, especially Technical Staff Members in bringing technological interventions for the benefit for farmers as desired by our Hon'ble Prime Minister, Shri Narendra Modiji. He also stated that the farmers are not getting proper return on investment and desired technical personnel to play key role in improving returns for farmers.
- Hon'ble Chairman welcomed woman representative looking at the only female CJSC Member present in the hall, Mrs Anuradha from NAARM. He also called for IJSC forums to play key role in institutes especially in eliminating red tapism. He also desired that women should be given enhanced representation at CJSC forum

- Before taking up further course of action of the meeting, Shri Chandrashekhar, Secretary (SS), CJSC conveyed thanks to Hon'ble DG, ICAR Dr.Trilochan Mohapatra and Hon'ble Secretary, ICAR, Shri Chhabilendra Roul for extending all their cooperation in addressing welfare matters. He also thanked previous Director General, Dr.S.Ayyappan for all his cooperation for CJSC. He expressed his belief that in future too CJSC would get similarly support from Dr.Mohapatraji and Shri Roulji and also from all Officers of the ICAR HQrs.
- Hon'ble Chairman then took up Action Taken Report of previous 36<sup>th</sup> CJSC meeting held on 23.12.2016. But he expressed his desire to discuss about progress if the same agenda item is reappearing in current list. While discussing ATR at Point 'C' Other issued raised, the Hon'ble Chairman wanted to support the demand of the CJSC for shifting date of implementation of revised qualifications prescribed for technical category for assessment from 24.04.2006 to 03.02.2000 subject to submission of undertaking by the beneficiary that he would not claim for monetary benefit for the period 03.02.2000 to 23.04.2006 but for notional purpose only. He asked TS Section of ICAR to look into the matter accordingly.
- Similarly, Shri Shailendra Shah of IVRI raised the issue of insisting for honorary degree
  at graduation level by some of the institutes like IVRI for assessment promotion to be
  declared as not correct since it is not mentioned in Technical Service Rules. He asked to
  submit a representation for effecting necessary instructions in this regard to all Directors
  for compliance.
- At Point E regarding upgradation of T-3 in KVKs of ICAR Institutes to the grade of T-4, Hon'ble Chairman asked the SMD and TS Section of ICAR to examine the same.
- At Point 'G', Shri Deepak Kaul of IISWC, Dehradun raised the issue of regularizing Temporary Status Casual Labourers (TSCLs) in SSS posts and on this issue the Hon'ble Chairman expressed his concern about TSCL and asked the Deputy Secretary (A) to look into the matter.
- Shri Kaul has also moved the issue of long pending Cadre Review for SSS employees and stressed its importance. In this connection, he narrated that SSS employees moving to T-1 category is subject to possession of technical trade certificate, especially for Workshop functional group thereby they are deprived of promotional avenues even though they have been performing the same in the fields/labs. Shri Kaul requested for relaxation of this qualification for SSS employees for moving to technical category to those who are performing such duties as done by T-1 personnel. In view of limited promotional avenues at the last stages of service, the importance of Cadre Review is also requested. Hon'ble Chairman expressed his concern and asked Shri Kaul to give a separate proposal suggesting the way and means.

Hon'ble Chairman then took up Agenda items of present 37<sup>th</sup> CJSC meeting in order.

1. Implementation of Union Cabinet's Decision taken on 16<sup>th</sup> June, 1997 vide Case No. 190/24/97, dated 29-04-1997 as communicated by ICAR on the same day to all ICAR institutes vide its Office Order No.15(8)/96-Estt-I w.e.f. 16.06.1997. Action against the

er Hong R HQ Cadre Officers for making hindrance in this regard and misleading/misguiding the higher authorities including the President of ICAR, Hon'ble Courts and Hon'ble House of Rajva Sabha.

Hon'ble Chairman informed the house that ICAR is putting all efforts in resolving the issue. He also appreciated the efforts of Secretary, ICAR on this issue. He further informed the house that Ministry of Finance raised some queries on Pay Parity and Council is trying to furnish reply to MoE. Hon'ble Chairman also informed the house that the Hon'ble Union Minister of Agriculture & Farmers Welfare assured to take up this issue at his level for the cause of employees.

The house was also informed that the issue of Unification of Administrative Cadre is being placed before the 240<sup>th</sup> Governing Body meeting scheduled on 28.06.2017.

2. Framing of (a) Rotational Transfer Policy (b) Uniform Transfer Policy as per DoPT guidelines and CVC instructions – Transfer of HQ Cadre Officers/Institute Cadre Officers who have completed 5 years in Delhi to other parts of India outside Delhi.

Replying to various issues raised by Shri Chandrashekhar, Secretary (SS), the Hon'ble Secretary, ICAR stated that DoPT/CVC guidelines are followed by ICAR. Transfer Policy is not mandatory, but they are guidelines having a purpose with some limitations. He also expressed that the matter of Unification of Administrative Cadre which is under active consideration may solve this problem, if still exists.

At this stage, Shri V. Venu Nath, Member from CRIDA, Hyderabad brought to the notice of the house as how T-9 Technical Officer has been assigned the charges of DDO as well as Stores & Purchase Officer in spite of existence of all cadres of administrative staff and officers in the institute. Hon'ble Chairman stated that this is an issue of individual institute but still ordered to record the statement as such things are happening in some other institutes also in spite of repeated orders for not assigning such tasks to scientists/technical personnel. He asked to issue orders in this regard once again.

3. Implementation of the recommendations of the committee headed by Dr.Alagsundaram, DDG (Engg) meant for removing of anomalies in technical service conditions.

Shri Deepak Kaul, Shri Sheilendra Shah, Shri Nobi and other CJSC members raised issues relating to technical services including the deliberations of Dr.Alagsundaram Committee. In response, Hon'ble Chairman and Hon'ble Secretary, ICAR discussed the Points as below:

- 1. Relating to assigning higher pay for entire technical hierarchy, the matter was referred to MoE, who Informed that ICAR is waiting for reply from CSIR Min. of Higher Education., Coast Guard. As and when the same is received, it will be submitted to Internal Finance Division for examination & approved submission to MoF.
- 2. Regarding grant of 03 advance increments to technical service employees Dr.Alagsundaram committee not accepted 3 years assessment concept.
- 3. Regarding 2 year Diploma at p ar with 3 years dploma, house has Informed that the matter is under consideration and ICAR had asked financial implications from the institutes.
- 4. One time final Opportunity to Exercise option for old or New TSR, Proving three advance

increments to Ph.D holders Technical Officer and induction of Technical Officers of Category-III into scientific services, New TSR came into operation from the 03/02/2000 and hence relevancy of qualifications asked from the year 2000 instead of 2006. Hon'ble Chairman suggested to study /examine the issue.

- 5. Regarding Judiciary Pronouncement Court orders are specific to Deptt. Of Telecommunication. It is not applicable in ICAR. Therefore, DoPT also not agreed to its applicalling auto-mobility in ICAR.
- 6. Hon'ble Chairman suggested the Technical Section of ICAR to seek clarification from AICTE for equivalency in this regard when there was no 03-year Diploma in the subject during the particular year. Such cases have been resolved in IVRI's Engineering Section and NDRI in the past.

4. Counting of past service rendered by technical personnel on seeking transfer.

Hon'ble Chairman agreed to reconsider the issue.

5. Decentralization of recruitment of Group 'B' and 'C' posts from ASRB as the Board is only for recruiting scientific personnel/Group 'A' posts as per its mandate.

Directors of ICAR institutes were recruiting Group 'C' posts, namely LDCs, Stenographers and T-1 & T-3 posts. Eventually the job of recruiting these posts is entrusted to ASRB on the premise of recruitment irregularities at institute level. In doing so, majority of institutes lost the opportunity to recruit the candidates "specific" to job requirements. Now the recruitment has fallen out of frying pan into the fire as the ASRB is more scam-ridden.

Hon'ble Chairman stated that Institutes are facing problems in filling the posts and hence centralized recruitment was taken up. Shri Chandrashekhar, Secretary (SS) explained the delay in recruitment and doubts over ASRB's sincerity in the merit of recruitment.

6. Cadre Review for Administrative Cadre of ICAR after declaring the Admin. Officer posts as dying cadre and then unifying the cadres as per the decision of Union Cabinet.

Hon'ble Chairman informed the house that report of the Cadre Review for Administrative Category committee is being examined. Shri Chandra-shekhar, Secretary (SS) desired that cadre review to create more jobs at Assistant/AAO/AO level to mitigate the stagnation of Assistant/UDC/LDC Cadres.

Smt.Anuradha, CJSC Member of NAARM raised the issue of stagnation in Stenographic Cadre and requested for creation of PPS posts in institutes for creating promotional avenues.

Shri Deepak Kaul requested for creation additional posts for PS/ PPS to mitigate stagnation in Stenographic cadre and similar steps for JAO/ A&FAO cadre at institute level for better promotional avenues.

#### 7. Cadre Review of Skilled Support Staff (SSS)

It has been informed to the house that the Cadre Review Committee has already submitted its report which is under examination.

#### 8. Adoption of 5-Day Working for all ICAR institutes

Shri Chandrashekhar, Secretary (SS) stressed that CJSC platform has been requesting for 5-Day working in the ICAR Institutes since long. Hon'ble Chairman informed the house that ARS Forum also put forward its request for 5-Day working and accordingly all the Directors of Institutes have been asked to give their view point and reply to this is yet to be received from a few institutes. However, ICAR has meanwhile written a letter to DoPT on this subject. The matter is under examination.

#### 9. Holding of DPC for the vacant posts of AOs/FAO and above

DS(A) Informed the House that DPC was conducted recently and promotions were given. The matter regarding the seniority of DR and Promotees has been referred to DoPT.

#### 10. Any other agenda item with the permission of the Hon'ble Chair.

a) Shri Reyaz Ahmed Mir, CJSC Member of CITH, Srinagar requested to delegate the power to the Director, CITH for allowing non-entitled Officers/Officials of CITH to avail air travel during the course of blockage of National Highway on account of snow fall and also during the course of unrest/stone pelting/strikes/curfew/other restrictions. The matter stands discussed in the 26<sup>th</sup> of CJSC meeting held on 14-15<sup>th</sup> September, 2007 at NAARM, Hyderabad but formal orders of council with regard to delegation of powers to Director, CITH, Srinagar is still awaited despite of the recommendations of 11th IMC of CITH, Srinagar.

Action: DS(Hort.)

b) Shri Reyaz Ahmad Mir, CJSC Member of CITH, Srinagar also requested for conveying the approval of Competent Authority in Council for Recognition of Five Private Hospitals and Three Diagnostic Centre's Centers for availing the medical facilities by the staff of CITH, Srinagar as well as the staff of Regional Station(s) of NBPGR/IGFRI, Srinagar and KVK Baramulla as well as their dependent family members, As Srinagar is very remote and disturbed area and the facilities for healthcare is not so adequate, neither Srinagar is covered under CGHS. Further the proposal for recognition was also recommended by the 11th & 12<sup>th</sup> IMC of CITH, Srinagar and matter is still lying with SMD.

c) Shri Tarun Kumar, CJSC Member of CSSRI, Karnal and Shri Prabhjit Behl, CJSC Member of NDRI and Shri Rajeev Sharma, CJSC Member of ICAR Hqrs. requested for issuance of clear-cut orders as how to avail medical facilities and consultations of AMA.

In this connection, Official side clarified that employees can avail medical facility/AMA

services of other institutes located within the station as communicated to all institutes vide ICAR Lr.No.3(4)/95-Per.IV dated 5<sup>th</sup> June, 2009

d) Shri Chandrashekhar, Secretary (SS) requested for issue of communication stating that a person retiring from a place can register with any of ICAR institutes/dispensaries located in other stations for consultation as well as reimbursement of medical bills. This request is made as the retiring employees may remain in the same station or move to new place to settle down and in this process some of the Directors are not allowing to register them and instead insisting them to register with the institute where they had actually retired even though parent institute is located in a different station. This is causing lot of agony and hence orders to this effect is requested by Shri Chandrashekhar as ultimately the pensioner shall be utilizing medical facility from one place only.

This was agreed upon by the Hon'ble Chairman and noted down by Official side to issue necessary circular as the retiring people are likely to move to new place where they are going to settle down where their family resides or their native place or their place of choice as per their convenience.

e) Shri Rajeev Sharma, CJSC Member of HJSC enquired about status of Bonus in reply it has been clarified that the orders for autonomous bodies is still awaited and will be circulated as soon as orders are received.

f) The issue of 7<sup>th</sup> Pay revision arrears has been raised by members. Hon'ble Chairman informed the house that orders in this regard is expected in 10-15 days.

Action: Dir(P)

g) The issue of existing pensioners for implementation of 7<sup>th</sup> Pay revised pension has also be raised. It has been stated that orders in this regard for autonomous bodies is awaited as the matter was referred to Pensioners Welfare Department as well as DoPT.

Action: Dir(P)

h) Shri Rajesh Rai, CJSC Member from IIVR, Banaras requested to look into the issue of deduction of HRA from the employees who are not occupying the quarters allotted. He explained the condition leading to such situation and hence requested for stopping such unlawful act immediately.

Action: Dir(P)

i) Rajeev Kr.sharma raised strong objection on the language used by Secretary, Staff Side & stated that Secretary(SS) has created a big shift between the ICAR Hqrs. & ICAR Institutes on false and fabricated issues on wrong and mis-represented facts. He has further stated that the staff & officers are always remains helpful and in cordial relations to the offices & staff of Institute. He stated that & fighting attitude of the Secretary is neither useful for staff of Hqrs. Nor for Institute and therefore create harmful atmosphere of Hqrs. & Institutes.

Secretary, ICAR has endorsed the view & stated that pointing towards the ICAR Hqrs. Is a blame on him and rejected all blame raised by Secretary(SS) ought rightly.

j) Vide ICAR Letter No. 19(10)2004/Estt.IV dated 24.02.2006, amendments were circulated in Technical Service Rules. It is noticed that for production staff under Group V-subgroup B, duel qualifications(Degree & Diploma) are prescribed for Category II. For all other functional groups, either Degree or Diploma is prescribed as essential qualification. Hence this anomaly may be rectified urgently and equal justice may be given to production staff also.

Action: DS(TS)

k) After the inception of Technical service in 1975, 100 designation were abolished from different functional groups by the ICAR in 2012 vide administrative circular(2/2012) F.No. 19(16)2011/Estt.IV(Pt.) dated 04.05.2012. Majority of the anomalies existing in the Technical Service are denial/delayed service benefits with relation to their qualifications. The issue was discussed in detail as item No. XII in the 1<sup>st</sup> meeting of the committee constituted to examine the anomalies in the service matters in the Technical Service held on 13.10.2015. Under decision No. IV, a circular was issued vide ICAR letter F.No. TS-19(07)/15-Estt.IV dated 16.10.2015. But no further action is seen taken in this regard. Hence it is requested that necessary action may be taken to reclassify the existing designations in accordance with the qualifications available with the incumbents at that time to resolve the long pending anomalies.
