Sub:- 6<sup>th</sup> Central Pay Commission's recommendations – revision of pay scales – amendment of Service Rules/Recruitment Rules for the Fishing Vessel Crew.

Sir,

Consequent upon the implementation of recommendations of 6<sup>th</sup> Central Pay Commission from 1.1.2006, the revised pay structure comprising the pay band and grade pay has come into effect. Some of the pre-revised pay scales have been merged and some others have been upgraded. In the light of DoPT OM No. AB.14017/61/2008-Estt.(RR) dated 24<sup>th</sup> March, 2009, the recruitment rules for Fishing Vessel Crew notified vide ICAR letter of even number dated 19.8.2008 has been amended with immediate effect to substitute the existing scale by the grade pay along with the pay band as per Annexure.
