OFFICE MEMORANDUM

Subject Ceiling for reimbursement of special Nursing and Ayah/Attendant charges to the employees covered under CS(MA) Rules, 1944.

The undersigned is directed to invite reference to this Ministry's OM No.S.14025/74/86-MS dated 30.10.1991, wherein an arrangement for reimbursement for special nursing has been made which stipulates that the amount of such reimbursement is limited to the amount which is in excess of 25% of the pay of the Government servant. Keeping in view the increase in pay and allowances and wages of nurses and ayah/attendants and in order to simplify the existing procedure, it has been decided to fix ceiling rates of special nurse and ayah/attendant for reimbursement to CS(MA) beneficiaries.

2. The Ceiling rates for such reimbursement to CS(MA) beneficiary would be as follows.

|                |   |                                |
|----------------|---|--------------------------------|
| Special Nurse  | - | ₹ 150/- per shift of 12 hours. |
| Ayah/Attendant | - | ₹ 75/- per shift of 12 hours   |

3. The reimbursement of special charges for nurse and ayah/attendant at above rates is subject to the condition that for such purpose a certificate from the medical officer in-charge of the case in the hospital and countersigned by the medical superintendent of the hospital should be produced in the prescribed form as enclosed at annexure

4 This order will be effective from the date of issue
