The undersigned is directed to invite reference to the Office Memorandum of even number dated 7 th October 2010 on the above subject, vide empanelled hospitals under different categories the hospitals were notified and to state that as per the para (iii) of the Office Memorandum mentioned above the hospitals that are on the panel of CGHS who have did not apply in response to the fresh empanelment process initiated by the CGHS in second half of 2009 or have not been approved by CGHS under the fresh empanelment procedure can continue to treat CGHS beneficiaries at old(pre-revised) rates till 25th October 2010. On 26th October 2010, their names will stand removed from the list of approved hospitals empanelled under CGHS, without any further notice;

In this regard it is clarified that Primus Ortho & Spine Hospital, Chandra Gupta Marg, Chanakya Puri, New Delhi 10 021 would however, continue to be on CGHS, Delhi panel at old(pre-revised) rates till 11^{th} November 2010 (next date of hearing) as per the directions of Hon'ble High Court of Delhi in WP(C) No. 6720 of 2010 filed by 'Delhi Hospital Society Regd., 'v. Union of India and Others.
