Dear Colleagues,

During the recently held Interactive Meetings on Financial Matters, my attention was drawn towards the Quarterly Statement of Advances of a number of ICAR institutes wherein huge amount is shown under "Work-in-progress" of the on-going civil works under Plan. You are aware that 2016-2017 is the final year of the 12th Five Year Plan and from Financial Year 2017-2018 we may switch over to a different system of financing. Hence, it is essential that the various work-in-progress at your institute are completed by the end of this Financial Year i.e. by 31st March 2017 so that there may be no liability on account of 12th Plan in the subsequent financial years. You may personally monitor the pace of work and ensure their completion by the end of this Financial Year. In this connection, you are directed to submit, through your respective SMD, a detailed statement with regard to the on-going civil works, funds already released to CPWD against these on-going civil works and amount committed for release in the Current Financial Year (CFY) along with the likely completion time-line in respect of each of these Plan civil works, observing specifically that there wouldn't be any time or cost overrun at a later stage. It may also please be ensured that no new commitment is made on this account, which cannot be discharged by 31st March 2017.

Information with above details may please be forwarded to your respective SMD for compilation and a critical review by the Council. Matter may please be accorded top priority.
