**Subject: Amendment in Model qualifications for Research Management Positions in the ICAR system-Reg.**

Sir,

The revised model qualifications for selection of Research Management Positions and other Senior Scientific Positions in the ICAR, on lateral entry basis was issued vide ICAR letter No. 8 (1)/2007-Per.IV dated 26.04.2012 and subsequently amended vide letter No.8(2)/2013-Per.IV dated 29.10.2015 and 29.07.2016.


The alternative qualifications for 'Eminent Scientists' in Clause(ii) of S.No.7 & 8 of essential qualifications for the positions of DDGs/Directors of National Institute & other equivalent positions was amended to remove the condition requiring experience of RMP/some specified positions vide ICAR letter of even number dated 29.07.2016. However, alternative qualification for 'Eminent Scientists' has also been given in essential qualifications clause (ii) of S.No.06 of model qualifications dated 26.4.2012 meant for ADG/Directors of ICAR Institutes other than National Institutes/Deemed Universities/ ZPD (now ATARIs) and JD of National Institutes. On the recommendation of Governing Body of ICAR and with the approval of the Minister of Agriculture & Farmer's Welfare & President, ICAR the said qualification is amended as stated below:-

<b>6.</b> <b>ADG/ Directors of ICAR Institutes other than National Institutes/ Deemed Universities/ ZPD(Now ATARI) and JD of National Institutes</b>  (Minimum pay of Rs. 43000/- in the Pay Band - 4 of Rs. 37400-67000 with RGP of Rs.10000/-)	<p>(ii) At least 5 years' experience as Principal Scientist/ Professor or in an equivalent position in the pay band-4 of Rs.37400-67000/- with grade pay of Rs.10000/-.</p> <p style="text-align: center;"><b>OR</b></p> <p>An 'Eminent Scientist' having proven record of scientific contribution working in a reputed Organization/ Institutes having at least 15 years' experience in the relevant subject.</p> <p>Under this alternative qualification of 'Eminent Scientist', all those candidates shall be considered who have been (i) decorated with: National/International awards/ recognitions such as those conferred by National Organizations like ICAR, CSIR, DBT etc., Government of India, International Bodies of repute like FAO, UN etc., (ii) Fellows of one of the recognized National Academies viz., National Academy of Agricultural Sciences, National Academy of Medical Sciences, Indian Academy of Sciences, Indian National Academy of Engineering, Indian National Science Academy, National Academy of Sciences or equivalent National/ International Academies, and (iii) Minimum of 10 publication in journals having NAAS ratings (applicable from 01.01.2016)* of 7.5 and above. All the three conditions should have to be met simultaneously by the applicant to qualify under this clause.</p> <p>* The NAAS ratings, as and when would be revised in the future, shall be applicable for the purpose.</p>

The existing qualifications for the positions of ADG/ Directors of ICAR Institutes other than National Institutes/ Deemed Universities/ ZPD (now ATARI) and JD of National Institutes notified in S.No. 06 vide Council's letter no 8(1)/2007- Per-IV dated 26.04.2012 stands amended to the above extent.

The amended qualification will be effective on the positions advertised after the date of issue of this communique.
