Dear Mr. Ayyappan,

You are aware that Swachh Bharat Mission is being implemented across the country to achieve Swachh Bharat by October 2019. Swachh Bharat includes cleanliness in various Government offices and subordinate institutions, right down to the last tier. I had earlier requested that appropriate instructions may be issued in this regard. I am sure appropriate action is being taken at your end for the same.

2. The Swachh Bharat Mission was reviewed in a meeting chaired by Hon'ble Prime Minister on 11.06.2015. The Hon'ble Prime Minister has directed that in order to further encourage public institutions to maintain cleanliness we may consider initiating competition between different Wings of an Organization to increase the participation in the cleanliness drive and to reward the better performing ones. As an example, competitions can be held in hospitals, police stations, railway stations to award the best among them. We may also need to keep in mind sustainability of the cleanliness operations. It is not to be a onetime effort.

3. May I request that you may take further necessary action pertaining to your Ministry immediately on the above lines under intimation to this Ministry.
