CIRCULAR

It has been observed that requests for renewal of pensioners CGHS cards on annual basis are not being received on time from the pensioners/family pensioners. As a result, process of renewal of CGHS cards gets delayed which in turn causes difficulties to the pensioners who are in need of urgent medical treatment. In order to avoid this, all the pensioners/ family pensioners of ICAR Hqrs who are CGHS beneficiaries and whose CGHS cards are due for renewal from 1.07.2021 to 30.06.2022 may please submit their request immediately in order to ensure that their CGHS Cards are renewed timely. The pensioners should deposit the payment towards CGHS annual contributions on their part, if due, three months prior to the date of expiry of the CGHS cards. If requests are received in time, then the payment of funds to the CGHS directorate for renewal of the cards can be made timely. It may also be noted that renewal of CGHS cards can be done only after requests for the same are received from the pensioners/ family pensioners. A copy of proof of residence and copy/copies of CGHS cards in respect of pensioners and their eligible family members are also required with the application. The format of application is given overleaf.
