Reference is invited to Council's circular of even number dated 28.03.2012 on the above mentioned subject. In this context, it is stated that the matter regarding reviewing authorities for the Annual Performance Appraisal Report (APAR) (previously known as ACR/AAR) in respect of the administrative / finance category officers/ officers of Combined Cadres of AOs and F&AOs has been further considered / examined. It has been decided with the approval of the Competent Authority of ICAR that APARs in respect of officers of Finance cadre may be reviewed by Secretary, ICAR in situations when Financial Advisor, ICAR does not have adequate opportunity i.e. for 90 days and above to review the working of an officer under his Division and his work has been supervised by the Secretary, ICAR.
