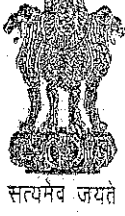

**Subject:- Installation of PV Solar Power Plants on rooftop and on ground in various organizations of Government of India- provision of 15% capital subsidy.**

Dear

*Secretary,*

I would like to draw your attention to my D.O. No.30/11/2014-15 dated 28.05.2015 wherein I had requested your Ministry/Department to set up 1 MW Solar Power Project on rooftop/land belonging to your Ministry or any of the organizations/PSUs/institutions under it.

2. A VGF of Rs.1crore/MW is being provided by Ministry of New and Renewable Energy (MNRE) under this CPSUs Scheme. However, some Ministries/Organizations have expressed difficulties in arranging the balance amount of the projects even after this VGF from MNRE. As under this scheme the projects have to be necessarily owned by the Ministry/Department/CPSU, it restricts the setting up of projects under RESCO Model, i.e. ownership of the projects by some private entity supplying power to the Ministry/organization concerned.

3. I would thus like to draw your attention to another scheme of MNRE called "Grid Connected Solar Power Projects Scheme" wherein a subsidy of 15% of the project cost is provided by this Ministry. This scheme also provides flexibility in terms of allowing RESCO Model of implementation and also the project size varies from 1 kw to 500 kw on single rooftop thereby accommodating smaller areas.

4. You may thus like to arrange to set up solar power projects in any of the Government of India organizations/CPSUs under your Ministry/Department. Copy of the scheme is available on Ministry's website [www.mnre.gov.in](http://www.mnre.gov.in), however, a copy is also enclosed herewith for ready reference.
