Sub : One time relaxation in Recruitment Rules for filling up of ADRP cleared DR posts into promotion & LDCE quota - regarding.

Sir,

A proposal for filling up of the Direct Recruitment (DR) vacancies of Lower Division Clerk (LDC) in the Grade Pay of Rs.1900/- at ICAR Hqrs. and in the various institutes of ICAR by the Seniority-cum-Fitness (SCF) mode of promotion and through Limited Departmental Competitive Exam (LDCE) in the ratio of 40:60, from the eligible Skilled Support Staff at the respective ICAR Hqrs./Instt., in relaxation of existing Recruitment Rules (RR) for the post of LDC, has been under consideration of the Council for quite some time.


2. It has been decided with the approval of the competent authority i.e., the Director General, ICAR that all those DR vacancies in the grade of LDC which have been recently cleared by the ADRP for the years 2006-07 and 2007-08 and approval thereon communicated to the Instt. vide ICAR letter No.33-12/2007-Estt.I(Pt.) dated 12th August, 2009 may now be filled up by promotion of existing eligible Skilled Support Staff in the Grade Pay of Rs.1800/- at the respective Instts. on seniority-cum-fitness and through Limited Departmental Competitive Examination in the ratio 40:60, as one time relaxation in the recruitment rules for the post of LDC. The vacancies already filled up by other mode of recruitment as per RR should not be reopened.

3. It has been further decided with the approval of the competent authority that the existing Skilled Support Staff of the respective Instts. in the Grade Pay of Rs 1800/- who fulfill the requisite minimum qualification of

matriculation and have rendered minimum 3 years regular service in the grade may also be made eligible to appear in the LDCE for the post of LDC, in relaxation of recruitment rules for the post of LDC.

The above mentioned decision is one time relaxation and hence shall not be applicable in future cases of recruitment. Necessary action in this regard may be taken on urgent basis.
