
Consequent upon restructuring of administrative and allied cadre posts in the ICAR including its Institutes etc, consolidated figures of the revised sanctioned strength for different categories of posts of ICAR, as approved by the Ministry of Finance (Department of Expenditure) vide their I.D.No. 2(25)/Estt.III Desk/2008 dated 23.06.2010, was communicated to all concerned vide ICAR office order No. 33(8)/2008-Estt.-I(Pt.) dated 03.08.2010. Consequently, proposal for refixation of sanctioned strength of the aforesaid post for all the Institutes of ICAR was under consideration of the Council.

2. Now, in supersession of all previous orders on fixation of sanctioned strength of administrative and allied category of posts for various Institutes of ICAR, as issued by the Subject Matter Divisions of ICAR or any other authority of ICAR from time to time, it has been decided that the institute wise revised sanctioned strength for administrative cadre, finance cadre, stenographic cadre and official language cadre posts shall now be as in the Annexure-I, Annexure-II, Annexure-III and Annexure-IV respectively.

3. After aforesaid refixation of cadre strength, there may be a situation at any Institute/NRC etc. where the man-in-position against a certain category/grade of post(s) will exceed the sanctioned strength. In that case, further recruitment or promotion against such post(s) may be halted completely and excess person(s)/strength in that cadre/post may be continued till the time the sanctioned strength gets corrected.

This issues with the approval of Director General, ICAR.
