OFFICE ORDER

A Committee had been constituted by the Indian Council of Agricultural Research (ICAR) under the chairmanship of Dr. R.S. Paroda, former Director General, ICAR to undertake a comprehensive review of the Agricultural Research Service (ARS) of the ICAR with the objective of bringing overall improvements and reforms in the service. The Committee has *inter-alia* recommended review of the existing transfer policy of ICAR in respect of ARS Scientists to make it more transparent and viable as a general reform for an effective scientific cadre.

In compliance with the recommendations of Dr. Paroda Committee, it has been decided to constitute a Committee to develop an effective transfer policy in respect of ARS Scientists with reference to the existing ARS guidelines on transfer and for recommending appropriate measures for postings and transfers of ARS Scientists in the NEH region and Andaman and Nicobar Island. The following will be the composition of the Committee:-
