Sub: Information regarding Casual Labours with Temporary Status (TSCLs).

Sir,

The Casual Labourers (Grant of Temporary Status & Regularization Scheme of Government of India, 1993, circulated vide DOPT OM No. 51016/2/90-Estt(C) dated 10.09.1993, stipulated conditions for grant of temporary status and regularization of services to the persons recruited on daily wage basis in the Central Government Offices as on 10.09.1993. The scheme of 1.9.1993 is not an ongoing scheme and the temporary status can be conferred on the casual labourers under the Scheme only if they were in employment on the date of the commencement of the scheme and they should have rendered continuous service of at least one year i.e. at least 240 days in a year or 206 days (in case of offices having 5 days a week). The Scheme inter-alia provided for regularization of CL-TS against Group 'D' posts.

A consolidated proposal for regularization of all such remaining CL-TS who were on the rolls of Ministries/ Departments on 10.09.1993 and yet could not be regularized may forwarded for further consideration/examination by DOPT

You are, therefore, requested to furnish the information of CL-TS in your institutes in the proforma overleaf immediately through mail (<u>rejeswari.icar@nic.in</u>) in <u>pdf format only</u> positively by **10.11.2014**. As the information is to be forwarded to DOPT immediately, no information received after the stipulated time will be entertain.
