

----- The undersigned is directed to draw attention to the Office Memorandum of even number No S.11011/12/2012/CGHS-(HEC) CGHS (P) dated 07.05.2013 vide which empanelment of **Babu Nature Cure Hospital and Yogashram, Mayur Vihar New Delhi** was restored initially for a period of six months and later on empanelment of Babu Nature Cure Hospital & Yogashram was extended repeatedly till 31.03.2015 on same terms & conditions as defined in the OM dated 7th May, 2013.
