This is in continuation of letter dated 31.05.2013. It is to inform that the contract for providing the cooking & catering services at IGH, Symposium Hall, conference facilities and in the lawn of NASC Complex and house-keeping services at IGH, NASC complex, Pusa, New Delhi-12 awarded to your firm is extended for a further period of one year w.e.f 01.06.2016 upto 31.05.2017 on payment of Rs. 3,60,000/- per month plus service tax as applicable.

The contract will be governed by same terms and conditions contained in the tender document and agreement signed with ICAR. The terms and conditions of the contract are reiterated as under:

- 1. An amount of Rs.5,00,000/- is to be deposited by way of Bank Guarantee from a nationalized bank in favour of Secretary, ICAR payable at New Delhi and valid upto 31.08.2017. Bank Guarantee will be returned after successful expiry of the contract.
- 2. Payment will be made based on monthly report of satisfactory services. TDS will be deducted from the payment applicable as per the rules.
- 3. In case of any loss or damage to the property of Council at IGH, Symposium Hall conference facility, NASC Complex shall be attributable to contractor and full damage will be recovered from the agency.
- 4. The agreement may be terminated with three month's notice from either side.

M/s Professional Group shall furnish a fresh agreement deed for the contract on a stamp paper of Rs. 100/- within 15 days of receipt of the letter. Applicable rates of catering services at Symposium Hall, IGH Cafeteria and various conference / meetings at NASC Complex are also attached. Please acknowledge this letter.
