Subject:- Compilation of information about appointments made on the basis of fake/ false: caste certificates- Recommendation of the Parliamentary Committee on the Welfare of SC/ST.

The undersigned is directed to refer to this Department's OM of even number dated 28.01.2310 or the subject cited above whereby all the Ministries/ Departments were requested to furnish information in relation to appointments made on the basis of fake/ false caste certificates, in prescribed proforma, by 31.3.2010, on the basis of the recommendation of the Parliamentary Committee on the Welfare of SCs and STs. The requisite information is still awarted in respect of some Ministries/ Departments though a considerable time has been elapsed. A copy of the OM dated 28.1.2010, s enclosed for your ready reference. It may be possible that some new cases havt; also come to the notice of the Departments! Ministries which has already furnished the requisite information.

- 2. The Parliamentary Committee on the Welfare of Scheduled Castes and Scheduled Tribes in its Second Report (15<sup>15</sup> Lok Sabha) have desired that information collected in relation to appoin ments made on the basis of fake/ false caste certificates should be furnished to them along-with the monitoring mechanism that would be devised by the Government.

### OFFICE MEMORANDUM

Subject:- Compilation of information about appointments made on the basis of fake/ false caste certificates-Recommendation of the Parliamentary Committee on the Weilfare of SCIST.

The undersigned is directed to say that the Parliamentary Committee on the welfare of Scheduled Castes and Scheduled Tribes in its Twenty-ninth Report (14th Lok Sabha) recommended that the Department of Personnel and Training should collect information regularly from all Ministries! Departments/ PSUs/ Banks/ Autonomous Bodies/ States/ UTs in regard to cases of false caste certificates. The recommendation is reproduced below:

- "..........DOP&T should interalia obtain information from all Ministries1Departments, PSUs, banks, autonomous bodies and States/ UTs in regard to cases of false caste certificates regularly with a view to monitoring their progress and disposal, so that necessary plan of action could be taken to tackle the problem for good."
- This Department's O.M. No.11012/1/9 I-Estt. (A) dated 19.5.1993 provides that if it is found that a Government servant had furnished false information or produced a false certificate in order to secure appointment, he should not be retained in service. Thus when an appointing authority comes to know that an employee had submitted a false/ fake caste certificate, it has to initiate action to remove or dismiss such an employee from service. Ministries Departments are requested to collect information from all Organisations under their administrative control about the cases where the candidates got/ allegize to have got appointment against vacancies reserved for SCs, STs and OBCs on the the basis of false/ fake caste certificate and sond a consolidated report in this
