Subject: Grant of honorarium for translation from regional language to English/Hindi & vice-versa.

In partial modification of this Department's O.M. No. 17013/3/86-Estt.(Allowance) dated 31<sup>st</sup> March, 1994 on the captioned subject, the President is pleased to decide that the rates of honorarium payable, subject to the ceiling of Rs. 5000/- per annum in each case for translation from regional languages to English/Hindi & vice-versa, will, hereafter be Rs.120/- per thousand words of Ordinary Material and Rs.130/- per thousand words of Technical Material (including Codes/Manuals, etc.)

2. In so far as persons serving in the India Audit & Account Department are concerned, this issues with the concurrence of the Comptroller & Auditor General of India.

4. These orders will be effective from the date of issue.
