The Joint Council Scheme of the ICAR was established in 1979 followed by various amendments/circulars/clarification etc. with the objective of promoting harmonious relations and securing greatest measure of co-operation between the ICAR and the General Body of its employees in matters of common concern, and for increasing efficiency of service. This scheme covers all employees under the ICAR (excepting Class I and above officers).

This Council has received several complaints regarding improper functioning / harassment/ Not conducting IJSC meetings timely/ not providing proper space to work to the IJSC members at different Institutes. Various new Institutes are also not holding elections at their Institutes on the ground of different justifications. Neither, the information sought by the Council on this subject are timely furnished to the Council to take remedial action.

All the Constituents Units of ICAR are, therefore, requested to follow the Joint Council Scheme of ICAR in its true spirit and furnish the following information to the Headquarters timely as :-

1. Quarterly Meeting of IJSC at the Institutes and its report in each quarter by the 7th of following quarter along-with action taken report on the problems/issues raised by the IJSC.

- 2. Timely Election of IJSC at your Institute and furnish the report within 15 days of constitution of new IJSC after the expiry of the tenure of existing IJSC.
- 3. Furnish the clarification on the issues/complaints regarding IJSC/CJSC, referred from the Council within 15 days to take remedial action on the matter.
- .4. Council may be referred before initiating any action against the IJSC/CJSC members so that recurrence of past actions taken by various Institutes may not be repeated in future.

This may be treated as Most Important and the receipt of this letter may please be acknowledged.
