## OFFICE ORDER

The President, Indian Council of Agricultural Research Society is pleased to appoint Dr. Gurbachan Singh, a permanent Member of the Agricultural Research Service (ARS) and presently on deputation as Agriculture Commissioner, Department of Agriculture & Cooperation, GOI, as Chairman, Agricultural Scientists' Recruitment Board, New Delhi with effect from the forenoon of 13th October 2011 on the following terms and conditions:

- 1. The term of appointment would be for a period of seven years with effect from 13<sup>th</sup> October 2011 or until further orders, whichever is earlier.
- 2. The pay scale of the post is ₹80,000/- (fixed).
- 3. The term of his appointment as Chairman, ASRB beyond the age of his superannuation i.e. for the period from 01.10.2016 to 12.10.2018 shall be regulated as that of a re-employed pensioner and consequently the pay of Dr. Gurbachan Singh shall be re-fixed as per instructions on fixation of pay of re-employed pensioners w.e.f. 01.10.2016.
- 4. He will be entitled to dearness, city compensatory and other allowances, encashment of leave, travelling allowances while travelling on duty, travel Concession during leave, travel concession while being released from service, leave, encashment of leave and other facilities for medical treatment as per entitlements.
