**Subject: Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission-Revision of pension of Pre-2006 pensioners/family pensioners of ICAR.**

Sir,

Consequent upon the revision of Pension of Central Govt. Pensioners on the recommendations of 6<sup>th</sup> Pay Commission, I am to inform you that the Council too have decided to implement the same as such to the existing pensioners/family pensioners of the ICAR. Accordingly, I am to forward herewith the copies of following O.M. issued by the Ministry of Personnel, Public Grievance & Pensions for information and necessary action:-

- (I) O.M.No. 38/37/08-P&PW(A) dated 1<sup>st</sup> September, 2008 with Annexature-1
- (II) O.M. No. 38/37/08 P&PW(A) Pt.1 dated 14<sup>th</sup> October, 2008 with Annexature -I to III

It is requested that the Pension/Family Pension of the existing pensioners as on 31/12/2005, who are drawing their pension through your Bank may be consolidated and revised w.e.f. 1.1.2006 as per para no. 4.1., 4.2 & 4.3 of O.M. cited at I above, in the prescribed proforma enclosed herewith and revised pension paid w.e.f 1.9.2008. **In the case of Pensioners belonging to scientific category, Para 4.2 of OM should not be applied as their revised Pay Band and grade Pay are yet to be decided in Council.** A copy of Statement of consolidation of pension of each pensioner may also be sent to the Finance & Accounts Officer of the ICAR, Institutes concerned, who have authorised the original pension for verification. The ready reckoner and table of concordance annexed to the O.M. may be made use of in consolidating and disbursing the pension.

It may be noted that arrears due to the pensioners for the period 1.1.2006 to 31.8.2008 may be worked out and 40% of which may only be credited into the account of the respective pensioners & balance 60% will be payable only in 2009-10 upon further instructions from the Council.

All the SBI Branches disbursing the pension of ICAR pensioners may be instructed accordingly. Copies of the O.M. 1 & 2 mentioned above are also available on the web page [www.persmin.gov.in](http://www.persmin.gov.in) of Ministry of Personnel, Public Grievances & Pensions for ready reference.
