In a Parliamentary Democracy, it is the innate right of a citizen to petition Parliament on matters of general public interest failing within the domain of the Government of India. Chapter X of the Rules of Procedure and Conduct of Business in the Council of States provides the instrument of the Committee on Petitions to examine such petitions and make reports thereon to the House. After the reports are presented by the Committee to the House, copies thereof are sent to the Ministries/Departments of the Government concerned for furnishing Action Taken Reports (ATRs) on the recommendations/observations of the Committee. For quite some time, it has, however, been observed that the Reports of the Committee are not being given due attention by the Ministries/Departments concerned and what to say of furnishing the ATRs in time, they are not even responding to any of the communications sent by the Secretariat of the Committee on its behalf, much less acknowledging them despite the fact that the communications by the Secretariat have been addressed to the respective Secretaries by name. To cite a few recent cases, the Ministry of Petroleum and Natural Gas took more than a year to furnish the ATR on the 123rd Report; the Ministries of Health and. Family Welfare and Women and Child Development took nearly eight months to fumish " on the 128th and 129th Reports of the Committee and that also after the ATRs Committee summoned their Secretaries to explain the reasons. Surprisingly, none of - these Ministries either acknowledged or responded to the communications/reminders addressed to their Secretaries. Similarly, the Ministry of Urban Development also did not acknowledge or respond to a communication sent by the Secretariat of the Committee for more than a year, much less furnishing the status of the action taken on the recommendation of the Committee as contained in its 119th Report. The Secretaries of all these Ministries tendered their applogles before the Committee for this lapse but the Committee had a feeling that some apathy/unresponsiveness had crept into the working of the Ministries and they seem to be unconcerned their their during of the Ministries and they seem to their duties towards Parliament and its Committees. be unconcerned about Surprisingly, one Joint Secretary of the Ministry of Women and Child Development who appeared before the Committee alongwith the Secretary of the Ministry on the 22nd January, 2007 strangely came up with the explanation that the communications about the ATR on the 129th Report of the Committee sent by the Secretariat of the Committee had not been acknowledged because the Ministry was not asked to acknowledge them, forgetting in the process that when the ATR had been called from the Ministry, for which a reminder had also been sent to them, they had either to furnish the ATR as desired or at least send an interim reply and if necessary seek extension of time or issue an acknowledgement. To say the least, If delays of this nature continue, the petitioners will · lose interest in submitting petitions and the credibility of the Committee on Petitions will be at stake.

I believe there exist adequate provisions in the 'Manual for Handling Parliamentary Work in Ministries' brought out by the Ministry of Parliamentary Affairs impressing upon all the Ministries/Departments of the Government to give utmost priority to all references received from the Secretariats of Parliament and the Ministry has'from time to time reiterated instructions to this effect but unfortunately they seem to remain on paper and are not being adhered to by the Ministries/Departments of the Government as borne out by the aforesald Instances.

The Committee in its meeting held on January 22, 2007 took a serious view of this lackadaisical approach of the Ministries and authorized me to write to you for urgent remedial/corrective action. I trust that having regard to the feelings of the Committee, you will do the needful in the matter on priority basis to ensure that the Ministries/Departments of the Government accord top priority to the Parliamentary matters and respond promptly to the communications sent by the Secretariat of the Committee with whatever information is desired from them.

I would appreciate if the Committee could be apprised of the action taken in the matter.
