SUB: Supply of drugs manufactured in India against prescription of Imported drugs marketed in India.

The undersigned is directed to refer to the subject mentioned above and to inform that a number of drugs are being imported and marketed in India by manufacturers/Importers of drugs. These drugs have identical pharmaceutical formulations and therapeutic value are being manufactured in India.

- 2. It has now been decided with the approval of the competent authority that whenever a request is received from CGHS beneficiary for issue of imported drugs and where equivalent drug manufactured in India is available, then only drug manufactured in India and containing identical pharmaceutical formulation shall be issued by Wellness Centre in future.
- 3. These instructions take effect from the date of issue of this Office Memorandum.
