- Shortlisted candidates for the above-mentioned positions shall be called for interview and the candidates shall be informed through email only before the interviews.
- All eligible candidates are requested to be present 30 minutes before the scheduled time on date of interview for necessary formalities.

In case of selection, the candidates will be required to present the original documents for verification along with four sets of the complete bio-data with self-attested photographs and self-attested enclosures such as mark sheets, proof of date of birth, certificates for qualification, experience, and caste certificate for submission in office at the time of joining.
